### Sustainable Houses of Worship and the Example of the Living Chapel

[40% of energy consumption and nearly 30% of all related greenhouse gas \(GHG\) emissions](#) every year emanate from the building sector. Faith for Earth issued the [Guidelines on Green Houses of Worship](#). The guidelines prominently featured the [Living Chapel](#), a holistic expression of the sacredness of life through a sustainable building that celebrates harmony with the natural world infused with serene architecture, art, and music. Faith for Earth continues to engage further with the Living Chapel, and similar projects and initiatives to facilitate sharing of best practices with all faith-institutions and houses of worship. ## [An Update of the Interfaith Rainforest Initiative](#)

The Interfaith Rainforest Initiative (IRI) over the past few weeks has organized several important meetings and published many important resources in all the countries covered by IRI. This included a [Conference](#) in Columbia, and the [IRI Columbia Advisory Council Video](#). While in Indonesia, IRI delivered a two-day training to leaders from Indonesia's religious councils on discussions on deforestation. In Peru, IRI worked on strengthening discussions on forest protection and restoration with the Minister of Justice, Agrarian Development, Environment through working meetings. In Brazil, IRI Advisory Council called on 30 religion, environment and indigenous leaders in Belém and Manaus to strategically install local chapters. Finally, IRI featured prominently in the discussions and recommendations of the G20 Interfaith Forum (2020). Under 'Taking Common Action to Protect the Planet', the G20 Interfaith Forum stated that "Faith-linked initiatives such as the Interfaith Rainforest Initiative (IRI) play pivotal roles in directing global attention to the challenges facing the world's rainforests." ## [Launch of Emissions Gap Report 2020](#)

UNEP's [Emissions Gap Report 2020](#) signals hope in a green pandemic recovery and growing commitments to net-zero emissions. The Report provides a yearly review of the difference between where greenhouse emissions are predicted to be in 2030 and where they should be. The world is still heading for a temperature rise in excess of 3°C this century – far beyond the Paris Agreement goals of limiting global warming to well below 2°C and pursuing 1.5°C. ## [A River with Rights](#)

On 15 December 2020, our partners the Lutheran World Federation, with other partners, organized a [webinar discussion](#) in the framework of the 5-year anniversary of the Paris Agreement. The event explored the case of the Río Atrato, how the rights of a river can be recognised, how rights to a healthy environment and food are linked, and how they can contribute to building more resilient communities. Our colleague Dr. Musonda Mumba, Chief Terrestrial Ecosystems Unit of UNEP gave a great talk on the UN Decade on Ecosystem Restoration in the context of the rights of rivers. The event was inspired by the indigenous peoples perspectives presented during the webinar.

## [Webinar for Major Groups and Stakeholders: Understanding the United Nations Environment Assembly \(UNEA 5.1\)](#)

The Civil Society Unit of UNEP is organizing an important webinar for **Accredited** Major Groups and Stakeholders to help understanding the United Nations Environment Assembly. The Webinar will be held on Wednesday, January 20th, 2021, 15:00 EAT Eastern Africa Time for a three-hour session. The three hour-session will take participants through the UNEA system, unravelling the process of negotiations, explaining how to influence sessions, understand policy complexities, and explain the political importance of the Medium-Term Strategy, the MTS, and the Programme of Works, the PoW. The MTS, which will be decided on by UNEA 5.1, is the work priorities and policy directions for the UNEP for the next four years. Formal invitations together with a link for registration will be sent out in early January 2021.

- Opportunity to challenge results: February 7 - 14 2021
- Endorsement of new members of MGFC by UNEP: February 15, 2021


