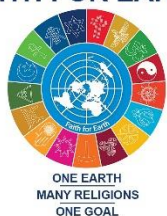

It is with pleasure to inform you that the Government of Iceland has approved convening a Global Faith for Earth Conference “**Faith Action for Nature**” during the first week of October 2020. This will mobilize faith actors’ contribution to the fifth session of the United Nations Environment Assembly (UNEA5) and in support of the Faith for Earth Coalition. The hybrid conference will have a limited in-person high level segment in Iceland and a digital global conference extending to all regions of the world. The Ice team and Faith for Earth are working on the details, concept, agenda, participation, and modality of the global and regional components. The event convened to discuss the critical interplay between religious beliefs, international actors and organizations, national and communal environmental policy and interstate issues, and initiatives as seen by master's students at Princeton who presented and discussed several papers related to the state of play of religions, development, economic growth and the environment. ## **G20 Interfaith Summit Consultation meeting**

Faith for Earth was invited as a key note speaker of the environment pillar at the G20 Interfaith Forum for the Arab Region as part of the global consultation process led by [KAICIID](#) based in Vienna. The Interfaith Forum aims to facilitate the necessary dialogue between relevant stakeholders to support the creation of an G20 engagement group consisting of interfaith communities. The COVID-19 crisis refocuses global agendas and calls for timely analysis and policy counsel. With the G20 deeply involved in global crisis management, the Interfaith community, which is also actively involved in response, will address urgent issues and pertinent policy recommendations, in parallel with but integrated in the continuing G20 Interfaith agenda. These consultations will present priority recommendations to the G20 Member States before their November 2020 Summit in Saudi Arabia. Panel Speakers were: **H.E. ## **How to prevent the next global pandemic**

[A landmark scientific assessment](#) is now out that explores how countries can prevent future pandemics like COVID-19. The publication, "[Preventing the next pandemic: zoonotic diseases and how to break the chain of transmission.](#)" finds that in recent decades there has been a surge in zoonotic diseases—potentially deadly pathogens that jump between animals and humans.

COVID-19 is a prime example, but Ebola, SARS, Zika and West Nile Virus also have their origins in the animal world. In fact, 60 percent of the microbes that infect humans begin in animals. In a normal year, these contagions kill at least 2 million people. This new report, a joint product the United Nations Environment Programme and the International Livestock Research Institute, finds that unless we adopt an integrated approach to healthcare, one that takes into account people, animals and the environment, we'll face more potentially catastrophic outbreaks in the years to come.

## **Religious Leaders Reaffirm their pledge to the UN Charter**

On 26 June, the UN marked the 75<sup>th</sup> anniversary of the signing of the UN Charter, the founding document of the Organization. We commemorate this day at a time of great disruption where the United Nations has become more crucial than ever in [leading and addressing global challenges](#) to protect our planet, end poverty and ensure prosperity for all as part of the sustainable development agenda. Faith leaders have also taken part to reaffirm their continued commitment to the Charter.
