**Annotation**

Under this agenda item, the Session will review the implementation of decisions and recommendations emanating from the Third Session of the Working Group.

The Working Group at its Third Session made 13 decisions concerning three substantive areas, namely: (i) Communications among Working Group members; (ii) Guidelines on travel by air of persons with disabilities; and (iii) Preparations for the 2017 midpoint review of the Asian and Pacific Decade of Persons with Disabilities, 2013-2022. It also made five recommendations with regard to specific actions to be taken by the Working Group and ESCAP member States in the above areas.

The ESCAP secretariat will brief the Working Group on the status of implementation of decisions and recommendations, and Working Group members will also be invited to present the progress in implementation of the decisions and recommendations falling under their responsibilities. In addition, a representative from the International Civil Aviation Organization (ICAO) will present the international standards regarding transport of dangerous goods by air, particularly on exemptions for passengers travelling by air with motorized wheelchairs, other mobility aids and medical devices.

Working Group members are invited to comment on the implementation.

The presentations and deliberations, as well as decisions and recommendations to emanate from this agenda item, will be reflected in the report on the Session.
