1. History of UI in Vietnam

- Before 1986: under the model of planned economy, there had no concept unemployment in Vietnam
- 1986-2009: the Government issued regulations to support the unemployed, mainly focus on the redundant workers from SOE restructuring (5 decisions, 3 decrees, 1 ordinance had been issued)
- 2009-2014: UI schemes was identified and implemented via the Social Insurance Law (compulsory SI, Voluntary SI and UI)
- Since 1 Jan. 2015: UI schemes has been implemented via the Employment Law (Employment creation, LM information, National occupational skills, Employment Services, UI).
