

**First Meeting of the SAARC Gender Policy Advocacy Group (GPAG)  
Hotel Marriott, Islamabad  
26-27 July 2015**

**ANNOTATED AGENDA & PROGRAMME**

**A. Background:**

In 2005, Member States of SAARC undertook the establishment of the SAARC Gender Info Base (SGIB), a South Asian repository of qualitative and quantitative data and information on gender related issues and women empowerment, in partnership UN Women. In June 2011, at the Fifth SGIB Review Meeting, Member States proposed the setting up of a Gender Equality and Empowerment Programme (SAGEEP), moving from a project approach to a programmatic one, which can be used to implement all SAARC activities related to women. SAGEEP was approved by the Fifth Meeting of the SAARC Technical Committee on Women, Youth and Children (TC – WYC) in July 2011 and later endorsed at the Seventeenth SAARC Summit in Addu City in November 2011. The Addu Declaration called for the convening of an Intergovernmental Expert Group Meeting to discuss the establishment of a regional mechanism to promote gender equality and the empowerment of women in the region.

The SAARC Intergovernmental Expert Group Meeting (IGEGM) was organized by SAARC Secretariat in partnership with UN Women and Government of Maldives, on 11-12 March 2013 in Male'. The meeting resulted in the establishment of the SAARC Gender Policy Advocacy Group (SAARC-GPAG) as a regional mechanism to promote gender equality and empowerment of women within SAARC. The Terms of Reference for the SAARC-GPAG finalized in the Meeting was revised by the Sixth Meeting of the TC – WYC, and approved by the Fortieth Session of the Standing Committee (Male', 19 February 2014).

The inaugural meeting of the SAARC-GPAG is scheduled to be held from 26 - 27 July 2015, in Islamabad and will be held once a year, preceding the SAARC Technical Committee Meeting on Women, Youth and Children, as per the directive of the Member States of SAARC.

### C. Objectives:

1. Identify common issues and provide policy advice.
2. Advocate to keep gender high on the policy agenda of the SAARC Member States:
  - a. Enhance political and administrative will on Gender Equality;
  - b. Ensure implementation of commitments by Member States to empowerment of women and Gender Equality;
  - c. Monitor and document progress.

### D. Expected Outcomes:

1. Progress on gender equality and empowerment of women in Member States shared and recommendations to enhance gender equality outcomes discussed and endorsed.
2. Cross-regional learning facilitated in select key thematic areas.
3. Key priorities for GPAG identified for 2015-2018.
4. GPAG operationalized and mechanism set up to draft a three-year Action Plan and a Strategic Results Framework.
