## Professor Joseph E. Stiglitz



Professor Stiglitz is University Professor at Columbia University in New York and Co-Chair of Columbia University's Committee on Global Thought. He is also the founder and Co-President of the Initiative for Policy Dialogue at Columbia. Prof Stiglitz chaired the UN Commission of Experts on Reform of the International Financial and Monetary System set up in 2009 in the aftermath of the Global Financial Crisis by the President of the UN General Assembly. Prof. Stiglitz has served as Chair of the Council of Economic Advisers in the United States during 1995-97 and as Chief Economist of the World Bank during 1997-2000. He won the Nobel Prize for

Economics in 2001 for his analyses of markets with asymmetric information. Prof Stiglitz also chaired the Commission on the Measurement of Economic Performance and Social Progress, which released its report in 2009 set up by President Sarkozy of France. Since 2008, Prof. Stiglitz has been the world's most cited economist and was named as one of the 100 most influential people in the world by *Time* magazine in 2011. In 2013, Stiglitz won the Daniel Patrick Moynihan Prize for his work on income inequality in the U.S. and its impact on public policy.

# Future of the World Economy and Globalization in the aftermath of global financial crisis: Implications for Developing Economies

At the Seminar, Professor Stiglitz and other panelists will take a critical look at the emerging economic trends in the world economy where advanced economies of the world continue to face subdued and uncertain economic outlook in medium term. New normal of subdued growth in the advanced economies-- the erstwhile growth poles of world economy-- and volatility of capital markets and exchange rates linked to their monetary policies are casting question marks on the future of globalization as an economic strategy. They will review the implications for developing and emerging economies like India.
