**Article 11**

Situations of risk and humanitarian emergencies

"States Parties shall take, in accordance with their obligations under international law, including international humanitarian law and international human rights law, all necessary measures to ensure the protection and safety of persons with disabilities in situations of risk, including situations of armed conflict, humanitarian emergencies and the occurrence of natural disasters."

- Some progress reported by 11 States Parties in Asia and the Pacific
- Few reported on involving persons with disabilities in different phases of disaster risk reduction

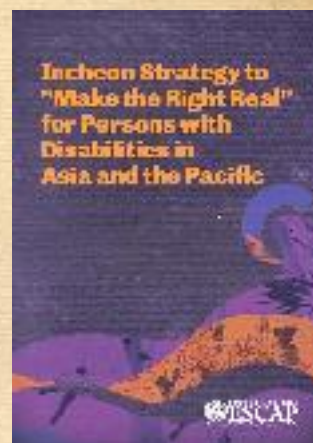
### Goal 7: Ensure disability-inclusive disaster risk reduction and management

#### Target 7.A

Strengthen disability-inclusive disaster risk reduction planning

#### Target 7.B

Strengthen implementation of measures on providing timely and appropriate support to persons with disabilities in responding to disasters







## **Incheon Strategy promotes disability-inclusive disaster risk reduction**

### **Core indicators**


- 7.1 Availability of disability-inclusive disaster risk reduction plans
- 7.2 Availability of disability-inclusive training for all relevant service personnel
- 7.3 Proportion of accessible emergency shelters and disaster relief sites



## **Incheon Strategy promotes disability-inclusive disaster risk reduction**

### **Supplementary indicators**

- 7.4 Number of persons with disabilities who died or were seriously injured in disasters
- 7.5 Availability of psychosocial support service personnel that have the capacity to assist persons with disabilities affected by disasters
- 7.6 Availability of assistive devices and technologies for persons with disabilities in preparing for and responding to disaster



### Availability of data for Goal 7 IS indicators

- Goal 7 was one of the goals with lowest data records
- Less than 10 governments have disability-inclusive disaster risk policy
