




E-CUSTOMS PROCEDURE

- Until 15/08/2013: 34/34 Customs Department across the country and 148 customs branches implement e-Customs procedure.
- About 2,985 million of customs applications were completed electronically, accounting for 91.25 percent of the total submitted application forms
- The total import turnover reached 138.1 billions USD by e-Customs, account for 94.1% of total national imports and exports.
- As of 31/07/2013: The number of companies involved in e-customs is 42,096 companies, accounting for 94.7% of businesses make customs procedures across the country.

LEGAL DOCUMENTS

- Decree 87/2012/ND-CP detailing a number of articles of the Customs Law of the electronic customs procedures for export and import trade.
- Circular 196/2012/TT-BTC specified e-customs procedures for export and import trade.
- Decision 2341/QĐ-BTC decision on the issuance of the schedule using public digital signature in electronic customs procedures.
- The office of the General Administration of Customs 5559/TCHQ-CNTT guiding the implementation of digital signatures using public in electronic customs procedures.



DECLARATION METHOD

- Free software provided by GDC:
 - Type of business;
 - Type of processing;
 - Type of export production;
 - Software declared terminal (for declaration forms business, export production and processing), version. NET;
- Enterprise software is certified by building software compatible data transfer with the customs authorities provided



E-MANIFEST

- Decision No. 19/2011/QĐ-TTg on pilot implementation of received goods declarations, relevant documentations and e-clearance applied for vessels on entry, exit (e-customs procedures applied for vessels on entry, exit).
- The experimental area is divided into two phases:
 - Phase 2011 – 2012: Implementation at the city ports: Hai Phong, Da Nang, Ho Chi Minh and Ba Ria – Vung Tau.
 - Phase in 2012: Expansion of implementation at seaports in the provinces of Quang Ninh, Quang Ngai, Binh Dinh, Khanh Hoa and Can Tho City.
