E-Management (e-Queue) system has been introduced In order to increase the efficiency and transparency of the services provided by customs and for setting up the sequence of the receipt of the appeals form individuals,

“Information kiosks” were installed in order to provide information on the rules of customs clearance, import/export operations, tarif rates and customs payments, goods nomenclature, and other relevant information.






