Different Scenario

- ž Scenario 1: Government Agencies take lead to make Regulations without consensus from Private Sectors
- ž Scenario 2 : Private Sectors try to convince Government Agencies to make Regulations
- ž Scenario 3 : Government Agencies impose acts and joint with Private Sectors as committee to make regulations

Draft of Logistics Service Promotion and Development Act

- ž Logistics Defines as Services of procurement, deposit, storage, collection, transport, handling, forwarding, stuffing, inspection of goods, documents or related data of all mentioned activities
- ž Thai Logistics Services Business:

Thai Logistics Business defines as:

- ž Ordinary Partnership : wholly Thai Shareholders
- ž Limited Partnership : Unlimited liability must be Thai and registered capital not less than 51% must be Individual Thai Person
- ž Company Limited: not less than 50% must be Thai Director and not less than 51% Capital must be Thai
- ž Public Limited : not less than 50% must be Thai Director and not less than 50% capital must be Thai individual

Objective

1. To scope logistics services and measures to be used for promote aligned with economy, Trade social and environment
2. Promote fare competition
3. Promote and strengthen Thai Logistics services to be standard, reliable and competitive
4. Promote Logistics Thai to run business in overseas and create networks

Responsibility of Boards

- ž 1. Policy and Plan
- ž 2. Measure and condition to Promote Business
- ž 3. Report Development of Logistics Business
- ž 4. Recommend measures in Finance, Tax, Marketing, R&D, HRD, provide information and plan of development
- ž 5. Recommend measure of users protection
- ž 6. Improve and amend necessary acts and others

Privilege

1. Exempt or reduce Corporate Tax and VAT
2. User can deduct 50% of Service Fee as expense from Gross income to pay less Corporate Tax
3. Government Agency support to use service
4. Certify Status of LSP to deal with Authorities
5. Support financial and create capacity
6. Develop Knowledge and capability of LSP
