- Having seen the Royal Kram No: NS <sup>1/4</sup> RKM <sup>1/4</sup>40196 / 11 dated 24 January 1996 promulgating the law on the Establishment of the Ministry of Planning
- Having seen the Royal Kram No: NS <sup>1/4</sup> RKM / 0505/ 015 dated 09 May 2005 promulgating the Statistics Law
- Having seen the Sub-Decree No: 09 ANK/BK dated 26 January 2007 on the Organization and Functioning the National Statistical System
- Having seen the approved Letter No: 1264 SCHN of the Ministry of Interior dated 30 August 2012
- Having seen the approved Letter No: 074 DGH/DPHI of the Ministry of Health dated 30 August 2012
- Reference to the Necessity in improving the CRVS System.

## Decides:

### Article 1.-

To establish the Coordinating Working Group of CRVS System, and comprise of the following composition:

-Dr Khol Khemrany	Ministry of Health	Vice Chairman

-Dr Prak Sorphoanary	Ministry of Health	Member
-Mr Yim Sam Ol	Ministry of Interior	Member
- Mr Nit Sarun	Ministry of Planning	Secretary

### Article 2.-

The Coordinating Working Group of CRVS System shall have tasks as follows:

- a. Develop and implement the strategies/plans for survey data, census data, civil registration and health information in order to produce vital statistics.
- b. Direct/guide all technical works and coordination, e.g., development of technical papers/documents for survey data, census data, civil registration and health information in order to produce vital statistics.
- c. Solve all technical issues happening in the past, present and future activities of survey data, census data, civil registration and health information in order to produce vital statistics.

### Article 3.-

The Coordinating Working Group of CRVS System shall be assisted by advisors, experts, consultants from the development partners- they will assist all technical works relating to the survey data, census data, civil registration and health information in order to produce vital statistics.

### Article 4.-

The Coordinating Working Group of CRVS System can establish technical teams as per actual needs regarding the survey data, census data, civil registration and health information in order to produce vital statistics.

### Article 5.-

The Coordinating Working Group of CRVS System has to report to the Minister of Planning once

a month and copy furnished to Minister of Interior, Minister of Health and other related institutions about its achievements and challenges.

**Article 6.-**

Excellencies, Ladies and Gentlemen as in Articles 1 and 3 and other related institutions shall be responsible for implementing this decision that takes effect from the date of signature.
