

The external survey was distributed through a range of networks, including: Gender and Disasters Network (GDNET); the Global Network of Civil Society Organisations for Disaster Reduction (GNDR); the IFRC; ICVA; the UNDRR mailing lists on gender, Private Sector Alliance for Disaster Resilient Societies (ARISE), Stakeholder Engagement Mechanism (SEM) and Making Cities Resilient, the Women's Resilience to Disasters Knowledge Hub and additional partners of UNFPA, UN Women and UN DRR including a large network of women's organizations.

The development of the study was supported by the Government of Australia (Department of Foreign Affairs and Trade, DFAT) and the Swedish International Development Cooperation Agency (Sida).
