EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND JORDAN CONCERNING A LOAN BY THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND TO THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN DURING THE FINANCIAL YEAR ENDING MARCH 31, 1962. AMMAN, 15 AND 17 JULY 1961

Your Excellency,

Amman, July 15, 1961

I have the honour to refer to our recent discussions concerning proposals for an interest free loan by the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan during the financial year ending the 31st of March, 1962. Acting upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose to Your Excellency the following terms:

- (a) The Government of the United Kingdom will advance to the Government of the Hashemite Kingdom of Jordan an interest free loan of a sum of £500,000 sterling during the financial year ending the 31st of March, 1962.
- (b) The following table summarises the above proposals for the allocation of this year's development loan :

a. Desert Road Carpet	£200,000
b. Contribution towards outstanding debts on Desert Road . . .	£175,000
c. Jerusalem and District water supply	£75,000
d. Agricultural co-operatives and/or marketing and/or the Agricultural Credit Corporation	£50,000

TOTAL £500,000

The payment of £200,000 sterling for the Desert Road Carpet shall represent a contribution amounting to two-thirds of the total estimated expenditure on this item during the financial year ending March 31, 1962, in consideration of which the Government of the Hashemite Kingdom of Jordan will themselves provide the remaining one-third, amounting to the equivalent of £100,000 sterling.

- (c) The loan shall be repaid by the Government of the Hashemite Kingdom of Jordan to the Government of the United Kingdom in ten equal instalments of £50,000 sterling beginning on the 1st of April, 1967.
