Excellency :

I have the honor to refer to discussions which have taken place between representatives of our two Governments on the question of non-immigrant visas for treaty traders and treaty investors, and to confirm that the following is the understanding of the Government of the United States :

(1) The Government of the United States shall issue non-immigrant visas free of charge on a reciprocal basis to eligible nationals of France under the conditions set forth in the following schedule :

<i>Class</i>	<i>Visa symbol</i>	<i>Validity of visa</i>	<i>Number of times visa may be used</i>
Treaty trader, spouse and children	E-1	48 months	Unlimited
Treaty investor, spouse and children	E-2	48 months	Unlimited

(2) The Government of the United States shall, as required by Section 281 (5) of the Immigration and Nationality Act and Title 8 of the Federal Code of Regulations, paragraph 214.2 (e), charge a fee of \$10.00 for the issuance of each annual extension of stay to an eligible national of France who has been admitted into the United States as a treaty trader or treaty investor, and to his spouse and children.

(3) The Government of France shall issue visas of establishment free of charge on a reciprocal basis to an eligible national of the United States, for his initial entry into France as a treaty trader or treaty investor, and to his spouse and children.
