No. 6486. ZOOSANITARY AGREEMENT¹ BETWEEN THE GOVERNMENT OF JAPAN AND THE GOVERNMENT OF THE ARGENTINE REPUBLIC. SIGNED AT TOKYO, ON 20 DECEMBER 1961

The Government of Japan and the Government of the Argentine Republic, being desirous of cooperating to improve the zoosanitary conditions in the two countries, have agreed upon the following provisions :

Article 1

The Government of Japan and the Government of the Argentine Republic will notify each other promptly of the outbreak, recurrence and extent of animal diseases dangerous to livestock industry.

Article 2

(1) The Government of Japan and the Government of the Argentine Republic will exchange the regulations, periodicals, and other official publications that may be issued in the respective countries on the subject-matter of this Agreement.

(2) Both Governments will facilitate the exchange of scientific information in veterinary fields.

Article 3

(1) With a view to furthering the scientific and technical cooperation between the two countries in the fields of stockraising, zoosanitation and feeding-stuff, both Governments will promote the exchange of technical experts and trainees.

(2) Each Government will permit, in accordance with laws and regulations of each country, visits to that country of experts of the other Government for the purpose of studying and observing control measures against animal diseases and the effects thereof as well as zoosanitary conditions in its country. Each Government will facilitate as far as possible the studies and observations of such experts of the other Government.

Article 4

A certificate of origin or certificate of inspection of animal products, issued by duly authorized veterinary agency of either Government, shall be accepted by the authorities of the other Government, within the scope of laws and regulations of that other country, as proof of such origin or inspection. The issuance of such certificates by such authorized agency of that former Government shall not preclude, in accordance with laws and regulations of that other country, further inspection of the products by the authorities of the other Government or further investigation with respect to such products, to determine their freedom from infectious and contagious diseases, before entry is permitted.

Article 5

Each Government will study the method by which the titles acquired at veterinary colleges in the other country may be treated, within the scope of laws and regulations of that country, as equivalent in that country.

Article 6

This Agreement shall come into force on the date of signature and shall remain in force for at least one year from the effective date thereof. It shall remain in force thereafter, unless it is terminated by either Government by giving six months' written notice.

IN WITNESS WHEREOF, the undersigned, being duly authorized by their respective Governments, have signed this Agreement.
