My Lord :

I have the honor to refer to recent conversations between Representatives of the Government of the United States of America and of the Government of North Borneo and to put to the Government of the United Kingdom of Great Britain and Northern Ireland the following proposals with respect to the men and women of the United States of America who volunteer to serve in the Peace Corps and who, at the request of the Government of North Borneo, would live and work for periods of time in North Borneo.

1. The Government of the United States of America will furnish such Peace Corps Volunteers as may be requested by the Government of North Borneo and approved by the Government of the United States to perform tasks agreed by both Governments. The Volunteers will work under the immediate supervision of governmental or private organizations in North Borneo designated by the Government of North Borneo and the Government of the United States. The Government of the United States will provide training to enable the Volunteers to perform more effectively these agreed tasks.

2. The Government of North Borneo will accord equitable treatment to the Volunteers and their property ; afford them full aid and protection, including treatment no less favorable than that accorded generally to nationals of the United States residing in North Borneo ; and fully inform, consult and cooperate with representatives of the Government of the United States with respect to all matters concerning them. The Government of North Borneo will exempt the Volunteers from all taxes on payments
