The Embassy of the United States of America presents its compliments to the Secretariat of State for Foreign Affairs of Tunisia and refers to the letter dated 30 July 1962² from the Administrator of the Agency for International Development to the Secretary of State for The Plan and Finances in which the Government of Tunisia was informed that the United States Government is prepared to enter into an agreement to support the Government of Tunisia's Three-Year Plan. The Embassy is pleased to inform the Government of Tunisia that, subject to the appropriation of funds, the Government of the United States will provide assistance totalling up to \$180,000,000 during a period commencing July 1, 1962, under the terms and conditions set forth below, in support of the Government of Tunisia's Three-Year Plan.

This commitment is made under Section 202 (b) of the Foreign Assistance Act of 1961, as amended, relating to Development Loan Funds. It is expected that other forms of aid including Development Grants, programs under Title II and IV of the Agricultural Trade Development and Assistance Act of 1954, as amended, and Export-Import Bank of Washington loans, will be available. To the extent that such other forms of aid are provided the amount of this development loan commitment shall be reduced.

The above-mentioned assistance will be made available in accordance with the Agreement for Economic and Technical Assistance effected by an exchange of notes
