Excellency :

I have the honor to refer to the Agreement between the United States of America and Japan Regarding the Settlement of Postwar Economic Assistance to Japan which was signed on January 9, 1962² and entered into force on September 11, 1962 (hereinafter referred to as "the Agreement") and to the Notes dated January 9, 1962³ exchanged between our two Governments regarding the willingness of the Government of the United States to request the Government of Japan, pursuant to Article V, paragraph 1 of the Agreement, to make payment in the currency of Japan of the equivalent of \$25 million to be used for the purpose of educational and cultural exchange. I have further the honor to confirm that the two Governments have reached the following agreement regarding the manner of payment of the first and second installments under the Agreement :

1. Payment of the equivalent of \$12,500,000 out of the first installment which is to become due and payable on March 11, 1963 in accordance with Article I, paragraph 2 of the Agreement will be made in the currency of Japan.

2. With respect to the manner of payment of the second installment which is to become due and payable on September 11, 1963 in accordance with Article I, paragraph 2 of the Agreement, the two Governments agree as follows :

- (a) Payment of the equivalent of \$12,500,000 will be made in the currency of Japan on June 11, 1963 to be credited to the unpaid principal balance under the Agreement, provided that the budgetary appropriation necessary for such payment is made by said date.
- (b) With respect to the balance of the second installment, payment will be made on September 11, 1963 in the adjusted amount of \$9,381,000 as a result of the payment mentioned in (a) above.
