Excellency :

I have the honor to refer to conversations which have recently taken place between representatives of our two Governments relating to investment guaranties which may be issued pursuant to the present Agreement by the Government of the United States of America with respect to investments in Dahomey.

The Government of the United States of America and the Government of Dahomey, in order to facilitate and increase the participation of private enterprise in furthering the development of the economic resources and productive capacities of Dahomey by the issuance of United States Government investment guaranties, agree as follows :

1. The Governments of the United States of America and of Dahomey shall, upon the request of either of them, consult respecting projects in Dahomey with respect to which United States Government investment guaranties have been issued or may be issued pursuant to the present Agreement.

2. The Government of the United States of America shall not guaranty an investment in Dahomey under the present Agreement unless the Government of Dahomey approves the activity to which the investment relates and recognizes that the Government of the United States of America may guaranty such investment.

3. If the Government of the United States of America makes payment in United States dollars to any investor under a guaranty issued pursuant to the present Agreement, the Government of Dahomey shall recognize the transfer to the Government of the United
