AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE UNITED STATES OF AMERICA AND THE GOVERNMENT OF THE UNION OF BURMA ON THE USE OF UNITED STATES GOVERNMENT-OWNED BURMESE KYATS ACCRUED UNDER TITLE I OF THE AGRICULTURAL TRADE DEVELOPMENT AND ASSISTANCE ACT OF 1954, AS AMENDED. SIGNED AT RANGOON, ON 1 JUNE 1966

The Government of the United States of America and the Government of the Union of Burma :

Recognizing that substantial amounts of Burmese Kyats owned by the United States of America have accrued under the Agricultural Commodity Agreements of February 8, 1956, as amended,² May 27, 1958, as amended,³ and November 9, 1962 ;⁴

Considering that the intention of both countries in said Agreements was that said Burmese kyats would be used in a manner beneficial to both countries ;

Considering that the Government of the Union of Burma has expressed a desire to effect a fiscally sound disposition of said Burmese kyats ;

Considering that the Government of the United States of America is agreeable to the proposals by the Government of the Union of Burma for such a fiscally sound mutually beneficial agreement ; and

Desiring to set forth understandings which will govern the disposition of specific amounts of such Burmese kyats ;

Have agreed as follows :

Article I

The Government of the United States of America, subject to the terms of this Agreement, will grant to the Government of the Union of Burma 57,650,720.14 Burmese kyats and will loan to the Government of the Union of Burma the Burmese
