AGREEMENT¹ BETWEEN THE UNITED NATIONS EDUCATIONAL, SCIENTIFIC AND CULTURAL ORGANIZATION (UNESCO) AND THE PERMANENT EXECUTIVE SECRETARIAT OF THE "ANDRÉS BELLO" CONVENTION (SECAB)

The United Nations Educational, Scientific and Cultural Organization (UNESCO) and the Permanent Executive Secretariat of the "Andrés Bello" Convention (SECAB),

Considering

That UNESCO was created for the purpose of advancing, through co-operation between the nations of the world in the spheres of education, science and culture, the objectives of international peace and the common welfare of mankind, for which the United Nations was established, as is proclaimed in its Charter,

That the "Andrés Bello" Convention, concerning educational, scientific and cultural integration, is a treaty of international public law subscribed to by the Governments of Bolivia, Colombia, Chile, Ecuador, Peru and Venezuela for the integration of efforts in the fields of education, science and culture,

That the Third Meeting of Ministers of Education of the countries of the "Andrés Bello" Convention, by its resolution No. 24 of March 1972, established the Permanent Executive Secretariat of the "Andrés Bello" Convention (SECAB) as a subsidiary body of the Meeting of Ministers of Education of the signatory countries,

That consequently SECAB is called upon to deal, at a sub-regional level, with problems and activities that are in harmony with the matters pursued on a world scale by UNESCO,

Being desirous of co-ordinating their efforts with a view to pursuing their common aims within the framework of the Charter of the United Nations, the Constitution of UNESCO and the "Andrés Bello" Convention,

Having regard to decision 7.6 adopted by the Executive Board of UNESCO at its 97th meeting and to the decision adopted by the Meeting of Ministers of Education of the countries signatories to the "Andrés Bello" Convention at its Fourth Meeting (resolution No. 7),

Agree upon the following:

Article I. CO-OPERATION

1. UNESCO and SECAB agree to co-operate with each other through the appropriate organs of UNESCO and of the Meeting of Ministers.

2. This co-operation shall extend to all matters arising in the sphere of education, science and culture which are related to those tasks and activities of UNESCO and SECAB that are in harmony.
