AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE KINGDOM OF SWEDEN AND THE GOVERNMENT OF THE UNION OF SOVIET SOCIALIST REPUBLICS ON THE DELIMITATION OF THE CONTINENTAL SHELF AND OF THE SWEDISH FISHERY ZONE AND THE SOVIET ECONOMIC ZONE IN THE BALTIC SEA

The Government of the Kingdom of Sweden and the Government of the Union of Soviet Socialist Republics,

On the basis of the Agreement on principles for the delimitation of the sea areas in the Baltic Sea between the Kingdom of Sweden and the Union of Soviet Socialist Republics, dated 13 January 1988,²

Have agreed as follows:

Article 1

The demarcation line between the areas of the continental shelf over which Sweden and the Soviet Union exercise sovereign rights with respect to the exploration and exploitation of natural resources, and between the fishery zone of Sweden and the economic zone of the Soviet Union, shall consist of straight lines (loxodromes) connecting points having the geographical coordinates specified in article 2.

The demarcation line is calculated partly on the basis of the Swedish system of coordinates currently in force (RT 38), applied in Swedish nautical charts Nos. 7 and 8, printed in 1988, and partly on the basis of the Soviet system of coordinates, applied in Soviet nautical chart No. 1150, printed in 1987. The aforesaid nautical charts are annexed to this Agreement and constitute an integral part thereof.³

Article 2

The coordinates referred to in article 1 are as follows:
