AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE FEDERAL
REPUBLIC OF GERMANY AND THE GOVERNMENT OF
THE TOGOLESE REPUBLIC CONCERNING FINANCIAL CO-
OPERATION

The Government of the Federal Republic of Germany and

The Government of the Togolese Republic,

In the spirit of the friendly relations existing between the Federal Republic of Germany and the Government of the Togolese Republic,

Desiring to strengthen and enhance these friendly relations through financial cooperation as partners,

Aware that the maintenance of these relations constitutes the basis of this Agreement,

Intending to contribute to social and economic development in the Togolese Republic,

Have agreed as follows:

Article 1

(1) The Government of the Federal Republic of Germany shall enable the Government of the Togolese Republic to obtain from the Kreditanstalt für Wiederaufbau (Development Loan Corporation), Frankfurt am Main, financial contributions of up to DM 50,000,000 (fifty million deutsche mark) for the following projects:

- (a) A financial contribution of up to DM 15,000,000 (fifteen million deutsche mark) for the project "Structural assistance to support the implementation of a third adjustment programme, to be co-financed with the World Bank", provided that, after examination, the project qualifies for promotion;
- (b) A financial contribution of up to DM 13,000,000 (thirteen million deutsche mark) for the project "Electricity supply to Kpalimé", provided that, after examination, the project qualifies for promotion;
- (c) A financial contribution of up to DM 4,700,000 (four million seven hundred thousand deutsche mark) for the project "Transmission line Atakpamé-Notsé", provided that, after examination, the project qualifies for promotion;
- (d) A financial contribution of up to DM 5,000,000 (five million deutsche mark) for the project "By-pass road for Lomé", provided that, after examination, the project qualifies for promotion;
- (e) A financial contribution of up to DM 10,000,000 (ten million deutsche mark) for the project "Drinking water supply to the city of Sokodé", provided that, after examination, the project qualifies for promotion;
