EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF SWEDEN AND THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA CONCERNING UPGRADING OF DIPLOMATIC REPRESENTATION TO THE LEVEL OF AMBASSADOR EXTRAORDINARY AND PLENIPOTENTIARY

I

The Ministry for Foreign Affairs presents its compliments to the Legation of the Republic of South Africa and has the honour to inform the Legation that the Government of Sweden, in order to further promote relations between Sweden and the Republic of South Africa, is willing, on the basis of reciprocity, to upgrade its diplomatic representation in Pretoria to the level of Ambassador Extraordinary and Plenipotentiary. If this is acceptable to the Republic of South Africa, the Ministry proposes that this note and the note of reply of the Government of the Republic of South Africa constitute an agreement between the two governments on upgrading their diplomatic representations. The agreement enters into force on the day of the exchange of notes, at which time the agreement may also be made public.

The Ministry for Foreign Affairs avails itself of this opportunity to renew to the Legation of the
