Textes authentiques : anglais et italien. Enregistré d'office le 11 juin 1997. IMPLEMENTATION AGREEMENT<sup>1</sup> BETWEEN THE UNITED NATIONS AND THE GOVERNMENT OF THE REPUBLIC OF ITALY REGARDING THE USE BY THE UNITED NATIONS OF PREMISES LOCATED UPON THE ITALIEN AIR FORCE BASE IN PISA

WHEREAS, the Government of the Republic of Italy (hereinafter the "Government") and the United Nations (hereinafter "UN") on 23 November 1994 executed a Memorandum of Understanding Regarding the Use by the United Nations of Premises on Military Installations in Italy for the Support of Peace-keeping, Humanitarian and Related Operations<sup>2</sup> in which are set out the basic terms and conditions under which the Government may make available certain premises to the UN for its use in providing support to peace-keeping, humanitarian and related operations.

WHEREAS, the UN, represented by its Department of Humanitarian Affairs (hereinafter "DHA"), is presently occupying and using, pursuant to arrangements that predate the aforementioned Memorandum of Understanding, certain premises, including the land, buildings, related utilities, facilities, appurtenances or parts thereof located on the Italian Air Force base in Pisa (hereinafter collectively referred to as the "Premises"), a military installation operating under the authority of the Italian Air Force (hereinafter "ItAF").

WHEREAS, the UN is using the Premises as its logistic centre (hereinafter "UN Humanitarian Logistic Centre") for the purpose of providing assistance and support to its bumanitarian operations.

WHEREAS, the UN Humanitarian Logistic Centre has the task of gathering, conserving and distributing to areas struck by emergencies relief and survival goods, foodstuffs, and medical supplies for the purpose of contributing to meet the basic needs of victims of emergencies.

WHEREAS, Pisa is the location of the Headquarters of the ItAF's 46th Air Brigade, which will be implementing plans for development and subsequent infrastructural programmes that make it necessary in the near future for the ItAF to reacquire the Premises for its own use.
