- Arrangement between the Ministry of Economy, Industry and Trade of the Republic of Nicaragua and the Ministry of Transport of the German Democratic Republic on the deferment of payment for the transportation by sea freight of goods from the German Democratic Republic to the Republic of Nicaragua.
