Article XXVI of the Agreement states that, after an initial period of ten years, the Agreement 'shall be renewable for additional periods of five years', unless terminated by either Party. As the Agreement came into force on 2 November 2001, the initial period of ten years will expire on 2 November 2011. The Ministry has the pleasure to inform the Embassy that the Government of the Kingdom of the Netherlands proposes to renew the Agreement for an additional period of five years, until 2 November 2016.

The Ministry kindly requests the Embassy to confirm by diplomatic note that the Government of the United States of America agrees to the renewal of the Agreement for five years.
