**Arrangement on
Imports and purchases by the United Nations Integrated Office in Sierra Leone
of items for the exclusive and official use of the Military Guard Force
and on other related matters
supplementary to the
Agreement between the United Nations and Sierra Leone on the Status of the United
Nations Integrated Office in Sierra Leone**

The Executive Representative of the Secretary-General of the United Nations for Sierra Leone and the Minister for Foreign Affairs and International Cooperation of Sierra Leone;

Recalling the Agreement between the United Nations and Sierra Leone on the Status of the United Nations Integrated Office in Sierra Leone (UNIOSIL), signed at Freetown on ~~22 Dec~~2005 (“the Agreement”);

Recalling further that, pursuant to the Agreement, the Agreement between the United Nations and Sierra Leone Concerning the Status of the United Nations Mission in Sierra Leone (the “SOFA”) shall apply mutatis mutandis in respect, *inter alia*, of UNIOSIL and of the military personnel deployed by the United Nations Mission in Liberia (UNMIL) to Sierra Leone to provide security for the Special Court for Sierra Leone (the “Military Guard Force” or “MGF”);

Recalling paragraph 59 of the SOFA, as made applicable in respect of UNIOSIL and the MGF, in accordance with which the Executive Representative and the Government of Sierra Leone (the “Government”) may conclude supplemental arrangements to the Agreement;

Recalling paragraph 15 (a) of the SOFA, as made applicable in respect of UNIOSIL and the MGF, in accordance with which the Government recognizes the right of UNIOSIL and the MGF to import, free of duty or other restrictions, equipment, provisions, supplies, fuel and other goods which are for the exclusive and official use of UNIOSIL or the MGF or for resale in their commissaries;

Recalling paragraph 15 (c) of the SOFA, as made applicable in respect of UNIOSIL and the MGF, in accordance with which the Government recognizes the right of UNIOSIL and the MGF to clear ex customs and excise warehouse, free of duty or other restrictions, equipment, provisions, supplies, fuel and other goods which are for the exclusive and official use of UNIOSIL or the MGF or for resale in their commissaries;
