**AGREEMENT FOR THE ESTABLISHMENT OF A JOINT  
COMMISSION OF COOPERATION BETWEEN THE GOVERNMENT  
OF THE REPUBLIC OF SOUTH AFRICA AND THE GOVERNMENT  
OF THE REPUBLIC OF KENYA**

**PREAMBLE**

The Governments of the Republics of South Africa and Kenya (hereinafter jointly referred to as the “Parties” and in singular as the “Party”);

**CONSCIOUS** of the bonds between the two countries and of the necessity to promote and strengthen bilateral relations and other forms of cooperation;

**DESIROUS** to expand further on the Declaration of Intent on Cooperation between the Government of the Republic of South Africa and the Government of the Republic of Kenya signed on 5<sup>th</sup> August 2003 in Pretoria;

**HEREBY AGREE** as follows:

**Article 1  
Establishment of the Joint Commission**

The Parties herewith establish the South Africa/Kenya Joint Commission of Cooperation (hereinafter referred to as the “Joint Commission”).

**Article 2  
Purpose of the Joint Commission**

1. The purpose of the Joint Commission shall be to seek ways and means of promoting and enhancing cooperation between the Parties in, among other sectors: agricultural; cultural; economic; educational; political; security; sports; Science, technical and trade fields; and to coordinate initiatives in this regard as well as to facilitate contacts between the civil, parastatal and private sector structures of the Parties.
2. The Joint Commission shall:
  - a) Consider ways and means of promoting the objectives specified in Article 2(1) above and ensure the proper coordination and implementation of its decisions and/or recommendations;
  - b) Review the progress in implementation of all agreements between the Parties and consider and solve any problems that may arise from the implementation of such agreements;
  - c) Deliberate and conclude, among others, Sectoral Agreements as and when desired.
