NOTE VERBALE

The Embassy of the Republic of Serbia presents its compliments to the Ministry of Foreign Affairs and Cooperation of the Kingdom of Spain, and in connection with the experts' consultation meeting of 13 June 2013 in Madrid between a Delegation of the Ministry of the Interior of the Republic of Serbia and representatives of the Directorate General for Traffic of the Spanish Ministry of the Interior, at which consideration was given to the need to amend the Agreement between the Government of the Republic of Serbia and the Government of the Kingdom of Spain on mutual recognition and exchange of national driving licences concluded by exchange of Notes on 27 November 2008 and 9 March 2009, is honoured to propose the following amendments to the Agreement:

- Adding numeral "I" in Section 4, after the word "Annex".
- In Section 4, after the "C+E" category and before the "D" category the following categories shall be added: "D1, D1+E".
- Replacing the wording in Section 7: "[...] shall be recognized based on the technical tables of equivalents annexed to the present Agreement" with "[...] shall be recognized based on the technical tables of equivalents of Annex I to the present Agreement."

Annex I, which is the Spanish and Serbian table of equivalents for driving licences, and is part of the Agreement, shall be replaced by Annex I of the table of Serbian categories, which will cease to be valid as of 10 June 2017, and the Spanish categories, together with the Serbian table of equivalents that came into force on 1 January 2011, and the Spanish categories.

If the above-mentioned proposal is acceptable to the Government of the Kingdom of Spain, the Embassy of the Republic of Serbia suggests that this Note Verbale and the Note Verbale of the Ministry of Foreign Affairs and Cooperation of the Kingdom of Spain expressing its agreement with the proposal should constitute the Agreement on the amendments to the Agreement between the Government of the Republic of Serbia and the Government of the Kingdom of Spain on mutual recognition and exchange of national driving licences, which shall provisionally apply as of 30 days after the date of the receipt of the Note Verbale of the Spanish Ministry of Foreign Affairs and Cooperation and shall enter into force 30 days after the date of the last Note in which the two parties notify each other through diplomatic channels that their national procedures have been complied with for the Agreement to enter into force.

The tables of equivalents for the Serbian and Spanish categories of driving licences are attached to this Note Verbale as Annex I, which shall be considered to be an integral part of the Agreement on the amendments to the Agreement between the Government of the Republic of Serbia and the Government of the Kingdom of Spain on mutual recognition and exchange of national driving licences.

The Embassy of the Republic of Serbia avails itself of this opportunity to once again convey the assurances of its highest consideration to the Ministry of Foreign Affairs and Cooperation of the Kingdom of Spain.
