PROCÈS-VERBAL OF RECTIFICATION  
OF THE ORIGINAL OF THE CONVENTION

THE SECRETARY-GENERAL OF THE UNITED NATIONS, acting in his capacity as depositary of the International Convention for the Protection of All Persons from Enforced Disappearance, concluded at New York on 20 December 2006 (Convention),

WHEREAS it appears that the original of the Convention (Arabic, Chinese, English, French, Russian and Spanish texts) contains errors,

WHEREAS the corresponding proposed corrections have been communicated to all interested States by depositary notification C.N.737.2008.TREATIES-12 of 2 October 2008,

WHEREAS by 31 December 2008, the date on which the period specified for the notification of objection to the proposed corrections expired, no objection had been notified,

HAS CAUSED the corrections as indicated in the annex to this Procès-verbal to be effected in the authentic Arabic, Chinese, English, French, Russian and Spanish texts of the Convention.

IN WITNESS WHEREOF, I, Patricia O'Brien, Under-Secretary-General, the Legal Counsel, have signed this Procès-verbal.
