La Embajada del Japón saluda muy atentamente al Honorable Ministerio de Relaciones Exteriores, Comercio Internacional y Culto –Gabinete del Sr. Ministro– y, en relación con las recientes conversaciones entre los representantes del Gobierno del Japón y del Gobierno de la República Argentina, tiene el honor de proponer, de conformidad con lo previsto en el Artículo II del Convenio de Cooperación Técnica entre el Gobierno del Japón y el Gobierno de la República Argentina firmado en Tokio, Japón, el 11 de octubre de 1979 (en adelante se le denominará “el Convenio”), el siguiente acuerdo:

1. Los Programas Específicos de Cooperación Técnica (en adelante se les denominarán “los Programas”) que se pormenorizan en el documento anexo se llevarán a cabo por la Agencia de Cooperación Internacional del Japón, en el año fiscal japonés (en adelante se les denominará “el AFJ”) 2009 (que comienza el 1 de abril de 2009 y finaliza el 31 de marzo de 2010) de acuerdo con las leyes y reglamentos vigentes en el Japón.
2. De conformidad con el Convenio, el Gobierno de la República Argentina concederá los privilegios, exenciones y beneficios estipulados en el mismo a Expertos japoneses y sus familiares, así como los equipos, maquinaria y materiales relacionados con la implementación de los Programas.
3. Toda modificación o adición de los Programas en el AFJ 2009 se harán por un acuerdo entre las autoridades competentes de los dos Gobiernos. La autoridad competente del Gobierno de Japón es el Ministerio de Asuntos Exteriores, y la autoridad competente del Gobierno de la República Argentina es el Ministerio de Relaciones Exteriores, Comercio Internacional y Culto.
4. Los dos Gobiernos se consultarán mutuamente con respecto a cualquier asunto que pueda originarse de, o en relación con los Programas.

La Embajada del Japón tiene el honor de proponer que la presente Nota Verbal de la Embajada y la Nota Verbal de respuesta de ese Ministerio de Relaciones Exteriores, Comercio Internacional y Culto de la República Argentina, aceptando la propuesta arriba formulada, constituyan un acuerdo entre el Japón y la República Argentina, el cual entrará en vigor en la fecha de recepción de su nota de respuesta.

La Embajada del Japón renueva al Ministerio de Relaciones Exteriores, Comercio Internacional y Culto –Gabinete del Sr. Ministro– las seguridades de su más distinguida consideración.
