The Embassy of the United Kingdom of Great Britain and Northern Ireland presents its compliments to the Ministry of Foreign Affairs and Trade of the Republic of Korea and has the honour to refer to discussions which have taken place between the Governments of the two countries concerning the arrangements for the operation of the British Cultural Centre whose premises will initially be situated at 4F Hungkuk Life Insurance Building, 226 Shinmunro 1 Ga, Jongro Gu, Seoul, Korea 110-786

The activities of the British Cultural Centre will have the objective of fostering the development of relations between the two countries, through the exchange and dissemination directly to the public of information and knowledge, particularly in the fields of language and literature, culture and the arts, creative industries, education, science and technology, the media and communications.

The work of the British Cultural Centre in the Republic of Korea will be conducted by the British Council as the designated principal agent of the British Government for cultural activities overseas.

As a result of the discussions between our two Governments it is the understanding of the British Government that the following arrangements will apply to the British Cultural Centre ("the Centre"):

 The Centre will operate in accordance with the Cultural Agreement between the Government of the Republic of Korea and the Government of the United

- Kingdom of Great Britain and Northern Ireland signed at London on 21 April 1982, and the Exchange of Notes dated 26 and 31 May 1983.
- With the consent of the Government of the Republic of Korea, the British Council may in the future establish British Cultural Centre sub offices in the Republic of Korea.
- 3. The Government of the United Kingdom of Great Britain and Northern Ireland ("the British Government") will favourably consider the establishment of a Korean Cultural Centre in the United Kingdom in accordance with the laws and regulations in force in the United Kingdom.
- 4. The British Council will carry out its activities in accordance with the laws and regulations of the Republic of Korea.
- 5. The activities of the British Council on its own premises and elsewhere, may include:
- (a) disseminating information related to its role as a Cultural Centre in the Republic of Korea;
- (b) organising visits and events in the fields of culture, education and training, and science and technology; and administering scholarship programmes in these and related fields;
- (c) organising conferences, colloquia, and other meetings;
- (d) staging artistic performances, concerts and exhibitions;
- (e) showing films and audio-visual material;

- (f) receiving people involved in education and training, culture, science and technology to participate in activities organised by the British Council;
- (g) providing libraries, reading rooms and multi-media resource centres; and loaning books, newspapers, journals, audio-visual and other materials of a cultural, educational, scientific or technological nature;
- (h) publishing and distributing information bulletins, catalogues, and other materials of a cultural, educational, scientific or technological nature;
- (i) offering language courses, examinations and seminars; providing professional expertise and teaching materials to institutions and individuals, and co-operating to produce materials relating to teaching and teaching methods;
- (j) managing and participating in the implementation of bilateral and multilateral projects in accordance with the arrangements set out in this Note; and
- (k) arranging meetings and other activities for people of all ages.
- 6. In accordance with the arrangements set out in this Note, the British Council may also:
- (a) organise or participate in other events and activities;
- (b) organise events and activities outside their own premises and in partnership with other Organisations.

- 7. The British Council will be guaranteed free and unhindered public access to its premises and its activities where these are carried out elsewhere. The British Council will be permitted to publicise its activities by all available means. The British Council will also be permitted to enter into and maintain direct contacts with the relevant ministries and other public bodies, local authorities, non-governmental organisations, professional associations, and private organisations, individuals and groups.
- 8. The British Council is a non-profit-making organisation. The British Council is a charity registered in England and Wales. The British Council may charge for all or any of the activities listed in Paragraph 5 in order to cover some or all of the costs of their upkeep and operations. For example the British Council may:
- (a) charge visitors to attend their events, activities or exhibitions;
- (b) charge for language and other courses, examinations, or other related services;
- (c) charge for the use of libraries and the loan or sale of multi-media or other materials relevant to their activities;
- (d) sell catalogues, posters, programmes, books, records and teaching aids directly linked to the events and activities they organise;
- (e) run cafeterias for visitors to its offices.
- (f) The British Council may seek and receive commercial sponsorship to support its activities in accordance with the arrangements set out in this Note.
