Excellency,

I have the honor to refer to Note No. 2004/EÌGU/516455 of the Ministry of Foreign Affairs of the Republic of Turkey, dated December 8, 2004, and Note No. KTU/120/2004 of the Embassy of the Republic of Korea, dated December 1, 2004, concerning the operation permit for the Korea Trade-Investment Promotion Agency (hereinafter referred to as "KOTRA") office in Istanbul (hereinafter referred to as "the Office").

I have further the honor to propose that the Office be permitted to operate in Turkey for the promotion of trade and investment between the Republic of Korea and the Republic of Turkey, without any further operation-related permits by the Turkish authorities, taking into account the following points:

- KOTRA was established in 1962 under the Korea Trade-Investment Promotion Agency Act to promote trade and investment with foreign countries.
- The Office was opened in 1978 in accordance with Article VII of the Agreement of Trade Promotion and Economic and Technical Cooperation between the Government of the Republic of Korea and the Government of the Republic of Turkey, signed on May 5, 1977.

I have further the honor to propose that the resident representative and staff of the Office, who are appointed by KOTRA and who are not nationals of the Republic of Turkey, be granted work permits and residence permits during their tenure in Turkey by the Turkish authorities concerned.

If the above provisions are acceptable to the Government of the Republic of Turkey, I have further the honor to propose that this Note and your Note in reply to that effect shall constitute an agreement between the two Governments on this matter, which will become effective upon the exchange of our Notes and after the Republic of Korea and the Republic of Turkey notify each other of the completion of constitutionally required procedures for ratification, and shall thereafter be subject to termination by either Government giving three months' advance notice in writing to the other.

I avail myself of this opportunity to extend to Your Excellency the assurances of my highest consideration.
