AGREEMENT

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA

AND

THE GOVERNMENT OF THE REPUBLIC OF UGANDA

ON CO-OPERATION IN THE FIELDS OF

THE ENVIRONMENT AND WATER RESOURCES

PREAMBLE

The Government of the Republic of South Africa and the Government of the Republic of

Uganda (hereinafter jointly referred to as the "Parties" and separately as a "Party");

WILLING to strengthen the friendly relations and the strategic partnership between the

two countries;

DETERMINED to strengthen and deepen technical co-operation relations under the

Agreement on Technical Cooperation between the Government of the Republic of South

Africa and the Government of the Republic of Uganda;

CONVINCED that the environment and water resources on a national and global level

must be managed efficiently in the interest of present and future generations of

humankind, and that the policies and decisions must be geared to the guiding principle of

sustainable development along the lines of Agenda 21 as agreed to at the United Nations

Conference on Environment and Development ("UNCED"), held in Rio de Janeiro in

1992 and the Johannesburg Plan of Implementation as agreed to at the World Summit on

Sustainable Development held in Johannesburg in 2002;

RECOGNIZING the importance of co-operative efforts to promote environmental

protection and sustainable development of water resources;

EMPHASIZING that economic and social development, eradication of poverty and

provision of sustainable livelihood, as well as environmentally compatible management

of natural resources are integral and mutually supportive parts of sustainable

development of water resources;

WILLING to promote closer and long term co-operation in the field of the environment

and water resources;

HEREBY AGREE as follows:

ARTICLE 1 COMPETENT AUTHORITIES

The Competent Authorities responsible for the implementation of this Agreement shall be-

- (a) in the case of the Republic of South Africa, the Department of Environmental Affairs and the Department of Water Affairs; and
- (b) in the case of the Republic of Uganda, the Ministry of Water and Environment.

ARTICLE 2 CO-OPERATION

- (1) The Parties shall co-operate in the areas specified in Article 3 on the basis of equality, reciprocity and mutual benefit, taking into consideration their national environmental and water policies.
- (2) Co-operation undertaken pursuant to the provisions of this Agreement shall be subject to the domestic law in force in the territories of the Parties.

ARTICLE 3 AREAS OF CO-OPERATION

- (1) Co-operation between the Parties with regard to environmental issues shall include the following areas:
 - (a) Joint efforts to pursue the goals set by the UNCED and the World Summit on Sustainable Development (WSSD);

- (b) the exchange of views and experiences on instruments for environmental policy and management, as well as on the strengthening of environmental awareness by means of environmental education and participation therein of their citizens; and
- (c) exchange of information and technical support related to environmental legislation, policies, environmentally sound technologies and their applications in the areas of—
 - (i) biodiversity (wetlands, alien invasive species management, antipoaching);
 - (ii) land degradation and desertification; and
 - (iii)environmental management (pollution and waste management, environmental enforcement and compliance).
- (d) management of environmental and socio-economic impacts; and
- (e) any other related interests as may be agreed upon in writing by the Parties.
- (2) Co-operation between the Parties with regard to water issues shall include the following areas:
 - (a) Water resources management, including relevant policies and regulations;
 - (b) the formulation of water strategies, policies and planning such as South Africa's National Water Resources Strategy and its approach to Water for Growth and Development;
 - (c) design, construction and maintenance of large dams;
 - (d) rainwater harvesting in support of resources for poor farmers;
 - (e) transfer or pumping of water from large river systems;
 - (f) ground water exploration and rain water;
 - (g) flood and drought control measures; and
 - (h) any other related interests as may be agreed upon in writing by the Parties.
