AGREEMENT

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA

AND

THE GOVERNMENT OF THE REPUBLIC OF NAMIBIA

CONCERNING

THE TRANSFER OF EXAMINATION INFORMATION

PREAMBLE

The Government of the Republic of South Africa and the Government of the Republic of Namibia (hereinafter jointly referred to as the "Parties" and separately as a "Party");

WHEREAS Umalusi is a statutory council, which reports to the Minister of Basic Education of the Republic of South Africa and which is primarily responsible for quality assurance to general provision of and further education and training, and certifying successful candidates who have completed Adult, School and Technical College Education;

WHEREAS Umalusi endorses the certificates of candidates who have complied with the minimum requirements for admission to study at an institution of higher education and ensures that such certificates represent consistent standards of education and examination.

WHEREAS Umalusi maintains records of all certificates issued by itself to candidates;

AND WHEREAS the Ministry of Education of the Republic of Namibia wishes to obtain certificate information from Umalusi to enable the Ministry to issue certified statements to Namibian candidates in lieu of lost certificates which were issued on behalf of the Namibian state by the former South African Certification Council.

HEREBY AGREES as follows:

ARTICLE 1 INTERPRETATION

- In this agreement, unless the context indicates otherwise, the following expressions bear the meanings assigned to them below and cognate expressions bear corresponding meanings:
 - "Certification Data" means the data made available by Umalusi to the Ministry in terms of this agreement.
 - "Minister" means Minister of Basic Education of the Republic of South Africa.
 - "Ministry" means the Ministry of Education of the Republic of Namibia.
 - "Umalusi" means Umalusi, Council for Quality Assurance in General and Further Education and Training, established in terms of the General and Further Education and Training Act, 2001 (Act no.58 of 2001).
 - "days" means business days, being Mondays to Fridays, excluding public holidays within the Republic of South Africa.
 - "services" means the issuing of a certified statement by the Ministry to its clients.
- 2. Clause headings in this agreement are for convenience only and shall not be taken into account in its interpretation.

ARTICLE 2 COMPETENT AUTHORITIES

The Competent Authorities responsible for the implementation of this Agreement shall be:

- 2.1. In the case of the Government of the Republic of South Africa, the Department of Basic Education through Umalusi; and
- 2.2 In the case of the Government of the Republic of Namibia, the Ministry of Education.
