**PROTOCOL ON COOPERATION  
IN THE FIELD OF YOUTH  
BETWEEN  
THE GOVERNMENT OF THE REPUBLIC OF TURKEY  
AND  
THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF  
PAKISTAN**

The Government of the Republic of Turkey and The Government of the Islamic Republic of Pakistan, hereinafter referred as the "Parties".

Expressing their desire and interest to expand their relations and cooperation in the field of youth;

Convinced that cooperation in the field of youth will contribute to the further development of friendly relations between their countries and peoples,

Have agreed as follows:

**Article I**

**Purpose**

The purpose of this present Protocol is to encourage the development of relations and cooperation in the field of youth between Turkey and Pakistan on the basis of mutual interest and reciprocity.

**Article II**

**Fields of Cooperation**

1. The Parties shall cooperate in the following fields;

- Promoting reciprocal visits of their senior officials responsible for youth affairs,

- Inviting each other to the international festivals and competitions organized in their respective countries,
- Providing necessary assistance and facilities for their young people to attend international youth training courses organized in their respective countries.
- Organizing reciprocal visits and youth camps for their youth teams and promoting contacts and cooperation between their respective youth organizations,
- Exchanging information and experience in the field of youth,
- Promoting contacts and reciprocal visits between their youth experts.

2. The Parties shall encourage the cooperation and realization of bilateral youth exchange programmes between youth groups, communities and associations in the field of youth.

### **Article III**

#### **Implementation and Expenses**

1. This Protocol shall be implemented in accordance with the laws and regulations of the Parties.
2. The Parties may conclude additional sub-protocols or implementation programmes under this Protocol.
3. In the exchange of visits under this Protocol, unless otherwise agreed upon, the Parties shall cover international travel expenses of their teams and delegations, whereas the domestic travel expenses and the boarding and lodging expenses of those teams and delegations shall be borne by the Host Party.
