communicating the following:

In the Note from the Embassy of 4 February 2013 it was erroneously stated that the effective date for the application of the Agreement dated 25 May 2011 between the United Nations University and the Government of the Federal Republic of Germany concerning the Vice-Rectorate of the United Nations University in Europe and the Institute for Environment and Human Security was 12 December 2012. This information was incorrect in that the Agreement dated 25 May 2011 did not enter into force until 17 December 2012, the date on which both Parties informed each other that their internal requirements for such entry into force had been fulfilled. The relevant date was the date of receipt of the last notific-

Therefore, the Embassy of the Federal Republic of Germany proposes the following Arrangement correcting the aforementioned Agreement:

- 1. The date "12" cited in the Note of the Embassy of the Federal Republic of Germany of 4 February 2013 shall be corrected as follows: "17."
- 2. The corrected text shall replace the incorrect text ab initio.
- 3. The remaining provisions of the Agreement shall remain unaffected.

The Embassy of the Federal Republic of Germany requests confirmation of the receipt of this Note Verbale and your agreement.

The Embassy of the Federal Republic of Germany kindly requests the Rector of the United Nations University (UNU) to verify whether he could take on the task of registering the Agreement dated

25 May 2011 with the Secretariat of the United Nations, in accordance with Article 102 of the United Nations Charter.
