### MEMORANDUM OF UNDERSTANDING

### **BETWEEN**

# THE GOVERNMENT OF THE

### **REPUBLIC OF SOUTH AFRICA**

AND

### THE GOVERNMENT OF THE

# **REPUBLIC OF UGANDA**

ON

### **COOPERATION IN THE FIELD OF HEALTH**

#### PREAMBLE

The Government of the Republic of South Africa ("South Africa") and the Government of the Republic of Uganda ("Uganda") (hereinafter jointly referred to as the "Parties" and separately as a "Party");

**DESIRIOUS** to consolidate and strengthen the friendly ties and reciprocal understanding between the Parties;

**CONSCIOUS** of the desire to promote mutual knowledge, experience and understanding of their respective needs in human development by means of friendly co-operation between them;

**CONSIDERING** the importance of international co-operation and mutual interest of the Parties in promoting health at national, regional, provincial and local levels and strengthening their respective services,

**HEREBY AGREE** as follows:

#### ARTICLE 1

#### SCOPE OF MEMORANDUM OF UNDERSTANDING

The Parties shall undertake to promote, develop and increase the co-operation in the field of health and fight against diseases such as HIV and AIDS, tuberculosis, poliomyelitis, malaria and serious endemic conditions.

#### **ARTICLE 2**

#### **COMPETENT AUTHORITIES**

- The Competent Authorities responsible for the implementation of this Memorandum of Understanding ("MOU") shall be—
  - (a) in the case of the South Africa, the Department of Health; and
  - (b) in the case of the Uganda, the Ministry of Health.
- (2) If either Party changes its Competent Authority, the other Party shall be notified through the diplomatic channel of the designation of the new authority.

#### **ARTICLE 3**

#### **AREAS OF COOPERATION**

The Parties shall engage in joint capacity building in respect of the following pertinent health issues:

- (a) The control of HIV & AIDS and other infectious diseases;
- (b) the provision of pharmaceuticals & laboratory services through the exchange of technical assistance;
- (c) compliance with the International Health Regulation (2005);
- (d) human resource development;
- (e) building the capacity of Regulatory Health Professional Councils;
- (f) the provision of complementary medicine; and
- (g) improving compliance with health standards.

#### **ARTICLE 4**

#### FORMS OF COOPERATION

- (1) The Parties shall cooperate through—
  - (a) the exchange of information on matters related to health;
  - (b) twinning between the public hospitals of South Africa and Uganda; and
  - (c) biomedical research in relation to health systems.
- (2) The Parties shall exchange appraisal and evaluation missions from their respective countries to study, analyse and identify projects in areas referred to in Article 3.

#### **ARTICLE 5**

#### ADDITIONAL PROJECTS

In support of this MOU, the Parties shall conclude technical subsidiary agreements in respect of specific projects involving components of the areas of cooperation referred to in Article 3 and forms of cooperation referred to in Article 4.

#### **ARTICLE 6**

#### AMENDMENT

This MOU may be amended by mutual written consent of the Parties through an Exchange of Notes between the Parties through the diplomatic channel.
