AGREEMENT

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA

AND

THE GOVERNMENT OF THE HELLENIC REPUBLIC

ON

ECONOMIC COOPERATION

PREAMBLE

The Government of the Republic of South Africa and the Government of the Hellenic Republic, (hereinafter referred to as "the Parties" and in singular as a "Party");

DESIRING to promote the development of economic cooperation between the two countries, in areas of mutual interest, on the basis of equality, mutual benefit and reciprocity;

RECOGNISING the importance of long term measures for the successful development of the cooperation and the strengthening of ties between the two countries at various levels and, in particular, at the level of their economic operators;

TAKING into account their international obligations, in particular with regard to the African Union and its Member States as well as the Partnership Agreement between the Members of the African, Caribbean and Pacific Group of States on the one Part and the European Community and its Member States on the other Part and the European Community and its Member States on the other (Cotonu Agreement), and the Agreement on Trade and Development Cooperation(TDCA) between the European Community and South Africa;

HEREBY AGREE as follows:

ARTICLE 1 INTERNATIONAL OBLIGATIONS

In applying this Agreement ----

- (a) the Hellenic Republic shall respect the obligations arising from its membership to the European Union and
- (b) the Republic of South Africa shall respect the obligations arising from its membership to the African Union.

ARTICLE 2 OBJECTIVE

(1) The Parties shall make every effort to develop and strengthen economic cooperation, on as broad a basis as possible, in all fields deemed to be in their mutual interest and benefit.

- (2) The objective of this cooperation shall be aimed in particular, at ----
 - (a) strengthening and diversifying economic links between the Parties, and
 - (b) encouraging cooperation between economic operators, particularly small and medium sized enterprises, with a view to promoting investment, joint ventures, licensing agreements and other forms of cooperation

ARTICLE 3 COMPETENT AUTHORITIES

The competent authorities responsible for the implementation of this Agreement shall be —:

- (a) for the Government of the Hellenic Republic, the Ministry of Foreign Affairs and
- (b) for the Government of the Republic of South Africa, the Department of Trade and Industry.

ARTICLE 4 AREAS OF COOPERATION

(1) The cooperation provided for in Article 1, shall extend, in particular, to the following sectors:

- (a) Industry;
- (b) ship-building and ship repairing;

- (c) agriculture, including agro-industry;
- (d) construction and housing;
- (e) renewable energy sources sector;
- (f) transport, including maritime transport;
- (g) banking, insurance and other financial services;
- (h) tourism;
- (i) vocational training and management training; and
- (j) other service activities of mutual interest.

(2) The Parties shall consult with each other in order to identify the priority sectors that form part of their cooperation, as well as new sectors of economic cooperation.

ARTICLE 5 MODES OF COOPERATION

(1) The economic cooperation provided for in this Agreement, shall be carried out, mainly, on the basis of agreements and contracts between enterprises, organisations and firms of the Hellenic Republic and those of the Republic of South Africa, in accordance with the relevant legislation in the country of each Party.

(2) The Parties shall make every effort to facilitate this cooperation by creating favourable conditions for economic cooperation, in particular, by—

- (a) developing a favourable climate for investment;
- (b) facilitating the exchange of commercial and economic information;
- (c) facilitating the exchanges and contacts between their economic operators;
- (d) facilitating the organisation of fairs, exhibitions, symposia etc; and
- (e) encouraging economic activities.
