MEMORANDUM OF UNDERSTANDING

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA

AND

THE GOVERNMENT OF THE REPUBLIC OF BENIN

IN RESPECT OF

THE PROJECT OF CONSTRUCTION AND DEVELOPMENT OF THE INTERNATIONAL AIRPORT OF GLO-DJIGBE

PREAMBLE

The Government of the Republic of South Africa and the Government of the Republic of Benin (hereinafter jointly referred to as the "Parties" and in the singular as a "Party")

ACKNOWLEDGING that the Parties would like to cooperate in a project for the development of the International Airport of Glo-Djigbé;

RECOGNISING the potential benefits of this Project for the Beninese people and the interest it represents for the cooperation between the Republic of South Africa and the Republic of Benin;

RECOGNISING that the Parties intend to play a substantial and determinant role to enable the development of the Project, with the expectation that Airports Company South Africa SOC Limited will play a leading role in the completion of the Project, working with the Government of the Republic of South Africa, pursuant to definitive agreements to be concluded in relation to the Project.

NOTING that the Parties require investments and the provision of various services in relation to the Project through the various participants (or their affiliates), all as may be agreed from time to time;

NOTING FURTHER that the Government of the Republic of Benin will award a concession to and in favour of a company to be established for the funding and development of the New Glo-Djigbé Airport, and for the operation, management and provision of services related to the New Glo-Djigbé Airport for a period of at least 20 (twenty) years.

ACKNOWLEDGING that the Parties support Airports Company South Africa SOC Limited and all service providers and funders in their efforts to accelerate the airport's construction works, to develop and manage the Project;

HEREBY AGREE as follows:

ARTICLE 1 DEFINITIONS

For the purposes of this Memorandum of Understanding, unless the context otherwise requires-

"ACSA" means the Airports Company South Africa

SOC Limited, a company incorporated in accordance with the domestic law of South

Africa;

"Airport" means the new greenfield Glo-Gjibe airport

which shall be approximately 40km (forty kilometres) away from the existing airport;

"Aviation Facilities" means the development and completion of the

airport, including all aspects relating to the

project;

"Benin" means the Government of the Republic of

Benin, as may be constituted from time to

time;

"business day" means any day other than a Saturday, Sunday

or statutory holiday in the Republic of South

Africa or the Republic of Benin;

"Concession" means the duly authorised award by the

Government of the Republic of Benin of a concession to and in favour of a company to be established for the funding and development, maintenance and operation of the Glo-Djigbé Airport Facilities for the

duration of the Concessionary Period;

"Concessionary Period" means a minimum period of 20 (twenty) years

following completion of the Airport building as detailed in the definitive agreements to be

concluded between both Parties;

"DOT" means the Department of Transport of the

Republic of South Africa;

"Funding Participants" means the private financial entities in the who will participate in the implementation of the Project by assisting with facilitating the mobilisation of financial resources; "Implementation Agreement" means an agreement to be concluded between both parties and/or the Competent Authorities, and shall include the principal terms and shall, among other things: a. affirm the joint commitment of the Parties to the Project; b. create an enabling environment and for framework the necessary implementation of the Project; c. include defined milestones for the implementation of the Project following the Pre-feasibility Studies; d. set out the roles and responsibilities of the Participants in the Project; e. provide guidelines and mechanisms to be employed to expedite decisions that are required in order to facilitate the implementation of the Project; and f. set out the key principles as mutually agreed between the Parties. "Memorandum" means this Memorandum of Understanding as may be amended or varied from time to time and includes its annexures (if any) which shall form part of it; "MTPT" means the Ministry of Public Works and Transport of Benin, (MTPT) "Participants" means the entities in the Republic of South who shall take part
