The Embassy of the United States of America presents its compliments to the Ministry of Foreign Relations of the Republic of Peru and has the honor to propose to the Ministry two deployments of civilian, law enforcement unarmed aircraft to improve our joint counternarcotics program through the participation of United States Customs and Border Protection P-3 Orion maritime patrol aircraft in Operations Costa Norte and All Inclusive, joint and combined counternarcotics operations involving entities from the U.S. and Peruvian Governments. The Embassy of the United States requests approval for entry and flight operations for two (2) 10-day deployment periods to occur between August and December 2010. Deployments will be coordinated with the appropriate approving authorities, including the Peruvian Air Force.

The Embassy believes that the most effective U.S. aircraft for conducting counternarcotics maritime patrol missions, detection, and monitoring is the P-3 Orion. In addition, the Embassy believes that the participation of the Customs and Border Protection P-3 Orion maritime patrol aircraft will greatly enhance the success of these bilateral counternarcotics operations. The Embassy further believes that these counternarcotics surveillance flights by aircraft belonging to United States Customs and Border Protection and coordinated with the Peruvian maritime authority and Peruvian Air Force would fall under legal regulations pertinent to both parties and by the "Agreement to fight against the illegal use and the production and illicit drug trafficking between the Republic of Peru and the United States of America" signed on July 23, 1996. Specifically, and taking into consideration Article II of the above mentioned Agreement, Article V (a) of said

Agreement refers to executing joint strategies to prevent, control and suppress illicit trafficking in narcotics, and Article VI (c) refers to detecting, probable detention and interdicting of vessels and aircraft suspected of illicit transit of drugs.

In view of the above, the Embassy would like to request that the Ministry approve the two 10-day deployment periods to occur between August and December 2010, to allow Customs and Border Protection to conduct bilateral missions in support of Operations Costa Norte and All Inclusive. Deployments would consist of one or two unarmed P-3 aircraft with approximately 15 to 25 civilian U.S. personnel deploying to Peru to operate these aircraft.

During each deployment, the Embassy will provide the Ministry of Defense and the Ministry of Foreign Relations a daily report with all the information related to that deployment.

To ensure mutually beneficial participation of U.S. personnel in the deployment of the P-3 maritime patrol aircraft, the Embassy proposes that United States personnel hereafter deployed to Peru to conduct Operations Costa Norte and All Inclusive shall be given a status equivalent to that accorded to the administrative and technical staff of the Embassy of the United States of America under the Vienna Convention on Diplomatic Relations of April 18, 1961. In this regard, and for accreditation purposes, prior to each deployment, the Embassy will provide the Ministry of Foreign Relations and Ministry of Defense the list of United States personnel to be deployed in country for the execution of above mentioned operations, as well as the proposed dates for each deployment. In this regard, please find attached the abovementioned list of United States personnel.

If the foregoing is acceptable to the Government of Peru, the Embassy proposes that this note, together with the Ministry's reply, shall constitute an agreement between the two Governments which shall enter into force on the date of the Ministry's reply and remain in force through the completion of the operation.

The Embassy of the United States of America avails itself of this opportunity to reiterate to the Ministry of Foreign Relations of the Republic of Peru the assurance of its highest consideration.
