AGREEMENT ON THE PARTICULARITIES OF CUSTOMS TRANSIT OF GOODS TRANSPORTED BY RAIL

WITHIN THE CUSTOMS TERRITORY OF THE CUSTOMS UNION

The Governments of the Member States of the Customs Union within the
Eurasian Economic Community, hereinafter referred to as the Parties,

Based on the Treaty on the Customs Code of the Customs Union of November,
27 2009;

For the purpose of ensuring the application of customs procedure of customs
transit in respect of goods transported by rail within the customs territory of the
Customs Union,

Have agreed as follows:

Article 1

This Agreement defines the particularities of the customs transit in respect of
goods transported by rail within the customs territory of the Customs Union,
and does not apply to legal relationship connected with the movement of goods
and vehicles by individuals for personal use.

Article 2

For the purposes of this Agreement, the following terms and definitions shall
apply:

- 1) SMGS - Agreement on International Goods Transport by Rail of November 1,
1951;
- 2) Railways – company engaged in the transportation of goods by rail;
- 3) Railway of the Customs Union – a company of the Member States of the
Customs Union, engaged in the transportation of goods by rail in accordance
with the SMGS within the territory of one of the Member States of a Customs
Union;
- 4) Consignment – a SMGS consignment or a rail CIM/SMGS consignment
specified in the SMGS.

Other terms that are not specified in this article, shall be used in the meaning
established by the customs legislation of the Customs Union.
