The Embassy of the United States of America presents its compliments to the Royal Afghan Ministry of Foreign Affairs and has the honor to submit herein a proposed agreement which, if approved by the Royal Afghan Government, would permit the United States Government to pay the ocean freight costs of certain goods (as specified in Article 2 of the agreement) which might at some time or from time to time be sent to Afghanistan by voluntary, nonprofit relief and rehabilitation agencies in the United States pursuant to agreements between such agencies and the Royal Afghan Government.

Agreements of the type proposed below have already been concluded with the Governments of India, Pakistan, Lebanon and Iran, as well as with several European governments.

The Embassy wishes to point out to the Royal Ministry that acceptance of this agreement entails no obligation on the part of the United States Government to supply any of the goods covered by the agreement. Whether such goods will be sent to Afghanistan will depend entirely on agreements between the Royal Afghan Government and the voluntary, nonprofit agencies.

The text of the proposed agreement is as follows :

1. The Royal Government of Afghanistan shall accord duty-free entry into Afghanistan, as well as exemption from internal taxation, of supplies of goods approved by the Government of the United States, donated to or purchased by United States voluntary, nonprofit relief and rehabilitation agencies qualified under United States Government Regulations, and consigned to such organizations, including branches of these agencies in Afghanistan which have been or hereafter shall be approved by the Royal Government of Afghanistan.
