Nº 3445. PROTOCOL¹ ADDITIONAL TO THE AGREEMENT BETWEEN THE UNITED NATIONS INTERNATIONAL CHILDREN'S EMERGENCY FUND AND THE GOVERNMENT OF ITALY SIGNED ON 6 NOVEMBER 1947² CONCERNING THE ACTIVITIES OF UNICEF IN ITALY. SIGNED AT NEW YORK, ON 28 MAY 1956

WHEREAS, the General Assembly of the United Nations, by Resolution 802 (VIII) adopted on 6 October 1953³, reaffirmed the pertinent provisions of resolutions 57 (I)⁴ and 417 (V)⁵, but without reference to any time limit contained in those resolutions;

WHEREAS, in this same resolution, the name of the United Nations International Children's Emergency Fund was changed to the United Nations Children's Fund (hereinafter referred to as the Fund);

WHEREAS, the Government of Italy (hereinafter referred to as the Government) has expressed the wish to obtain assistance from the Fund in respect of the Trust Territory of Somaliland under Italian Administration.

WHEREAS, an Agreement was concluded on 6 November 1947² between the Government and the Fund in respect of the Fund's programmes of assistance to Italy;

NOW THEREFORE the Government and the Fund have agreed as follows :

1. Subject to the provisions of paragraphs 2 to 7 below the terms and conditions of the Agreement between the Government and the Fund signed on 6 November 1947 shall be extended to the Trust Territory of Somaliland.
2. *Article I* shall be replaced by the following :

PLAN OF OPERATIONS

“ A. On each occasion that the Government wishes to obtain assistance from the Fund it shall prepare a plan of operations describing the proposed project, the respective commitments proposed to be undertaken
